Membership Benefits

Membership Payment

- 1. The Foundation's membership year is July to June; however, membership can commence at any time and will automatically renew after each 12-month period.
- 2. Members fees where paid monthly, represents a contractual agreement to pay the full annual membership, by way of monthly payments, which will automatically renew each year. Members may request an invoice from the Foundation at the end of the financial year, if desired.
- 3. Payments can be deducted from a nominated credit card or bank account (Australian bank account only).
- 4. Membership fees are ongoing and auto-renewable. If a member wishes to cease membership the Foundation must be notified in writing.
- 5. Student membership fee covers the lifetime of study, until graduation.
- 6. Spinal Research reserves the right to increase the membership fees, however all members will be notified prior to changes being applied.
- 7. If a payment is declined, Foundation staff will attempt to process your payment again, and will make every effort to contact you if payments continue to decline. After 4 months of declines, and if there is no communication from you, your membership will be terminated, and you will be notified.
